Litigation

Mr. Del Valle has been successful in very relevant cases in federal and state tax and administrative litigation. Due to the outcome of litigation where he has represented clients numerous provisions of tax law have been either repealed or amended by Congress. Some of those cases are:

- Represented an international transportation company in obtaining a permit to operate in Mexico as a multi-national in transportation activities where a favourable final decision was obtained.
- Represented a company trading in gold in litigation against a tax credit of approximately US\$3,000,000,000 where a favourable final decision was obtained.
- Represented companies in the food sector in litigation against tax credits or refusals to grant tax refunds because of the 0% VAT rate applicability for amounts ranging between US\$10,000 to US\$300,000,000.
- Represented real estate funds in litigation because of tax credits issued by tax authorities because of international reorganizations.
- Represented clients in litigation against credits issued because of transfer pricing issues.
- Represented different companies in litigation on tax refund claims.
- Represented different companies in litigation on penalties.
- Represented numerous companies in litigation against legislation issued by Congress considered to have been issued in violation to the Mexican Constitution.

Tax Controversy

Mr. Del Valle has successfully represented numerous companies in tax examinations before the tax authorities, as well as tax refund claims, and controversies between tax authorities of different countries because of limitation of benefits, transfer pricing, exchange of information or applicability of Tax Treaties.
